1. Introduction

Finally, CSL is committed to ensuring environmental protection by enhancing the environmental performance of the organization, continuously improving environmental management practices, and raising stakeholder awareness.

3.1. Environmental Management

- Participate in training and awareness programs.

5.1 Monitoring

- Regularly monitor compliance with this policy through audits, assessments, and feedback from employees and stakeholders.

- Track and analyze data on responsible environmental management and associated consequences.

5.2 Review

- Review this policy annually and update it as necessary to reflect changes in laws, regulations, or company practices.
- Seek feedback from employees, suppliers, and stakeholders to improve the effectiveness of the policy.
